

## Newsletter – November 2017

### LMC Meeting 13<sup>th</sup> November 2017

At our last LMC meeting we discussed a range of issues, including A&E resourcing and extra bed capacity in the community, a proposal to create an 'Access LES' to replace the DES, drug administration cards and ordering of blood tests by district nurses.

### Rotherham Health Record – Information Sharing Agreement

There is a proposal that Information between RMBC, RDaSH, GPs and TRFT will be shared under a Rotherham-wide agreement. Opt-in by patients would be automatic unless they specifically opted out.

The document places the onus very much on the GP Practice to inform patients effectively, and refers to exclusion of patient information of a highly sensitive nature. It is not clear who decides and monitors this, and what are the consequences of mistakes.

As such, the LMC has serious reservations about this process and unless they are resolved we advise GP Practices to think very carefully before signing this.

### Updated Guidance – request for medical records from the police.

There is an updated pro forma for practices that receive requests for medical records from the police. The original pro forma was distributed in June 2017.

Following discussions with the NPCC (National Police Chief's Council) regarding signing off the BMA have agreed that the level of police seniority that they recommend to GPs to obtain before considering releasing medical records to the police is lowered from Superintendent to Inspector. They have restated to the NPCC the need for any request from the police for medical records is only made when absolutely necessary.

Please note that this is the only change to the guidance that has been made.

### Indemnity & MDU announcement

The government has pledged to roll out a state backed clinical negligence indemnity scheme for general practice in England. This move came after months of sustained lobbying by the BMA's GP committee and calls from GPs

across the country for government to recognise the scale of rapidly increasing indemnity costs over the last few years ((50% between 2010 and 2016).

Following the DH announcement, MDU advised that its membership benefits for GPs working under an NHS England contract who renew/join after 1st Nov will change to 'Transitional Benefits' intended to provide the indemnity until a state-backed scheme is introduced.

With the above information in mind, we would like to remind GPs of the requirement to maintain full indemnity cover before any change to a state-backed scheme in the future.
